If you have other family members on the plan, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .

Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care, office visit copayments, ambulance, and prescription drug copayments. <p>What is not included in the <u>out-of-pocket limit</u>?</p>	<p>The Medical Out-of-Pocket Limit does not include premiums, pre-certification penalty amounts, balance-billed charges, prescription drug copayments (for individual coverage), charges for mental health and substance use disorder treatment, and health care this plan doesn't cover.</p>	<p>Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u>.</p>
<p>Will you pay less if you use a <u>network provider</u>?</p>	<p>This plan only provides coverage when you use an in-network provider. ## About these Coverage Examples:



**This is not a cost estimator.** Treatments shown are just examples of how this plan might cover medical care. Your actual costs will be different depending on the actual care you receive, the prices your providers charge, and many other factors. Focus on the cost sharing amounts (deductibles, copayments and coinsurance) and excluded services under the plan. Use this information to compare the portion of costs you might pay under different health plans. Please note these coverage examples are based on self-only coverage.
